



Smart Controller Program

ELIGIBILITY:

- Participants must be Desert Water Agency customers in good standing with a valid DWA account number.
- Applicants must be the property owner or an authorized representative of the installation site.
- Participant must not have received a smart irrigation controller or controller rebate from DWA within the past five years.

Flexible Program

How it works

1. Contact DWA to ensure funding is currently available
2. Purchase a weather-based smart irrigation controller with rain shut-off capability
3. Get a receipt!
4. Install the device or hire a professional with a business license to install
5. Get an invoice from installer (invoice must have typed business information)
6. Submit the completed application, receipt/invoice to DWA

Basic program

Desert Water Agency selects a device appropriate for your home and sends out a professional to install the device. You will not be able to select which device we install, however you can pay for an upgrade option. This device will not be compatible with your smart phone. You will be required to be present for the installation. Installation schedule options are based on the professional's schedule and will require your flexibility. If you are unable to make yourself available you may be ejected from the program. Your device will be programmed to Desert Water Agency's watering schedule. Any device issues or maintenance will need to be handled through the device manufacturer. DWA will not be able to offer any technical assistance after installation.

CONDITIONS:

- Funding is limited. Controller and installation costs will be reimbursed on a first-come, first-served basis. Please inquire about funding levels before making your purchase (760-323-4971 or rebates@dwa.org).
- The participant agrees to leave the controller in place for a minimum of five years unless ownership of the property changes.
- Participants must agree to program and maintain programming for the device with Desert Water Agency watering schedule.
- Basic program participant must agree to have DWA installer at the home and be present for the installation.
- Flexible program Smart controller purchased must use weather data (cellular, WiFi or wired weather sensor) and have rain shut-off capability.
- In-store and online purchases from any vendor are eligible for the flexible program as long as device meets criteria.
- A receipt from the past 45 days must be provided listing the smart controller.
- If DWA finds that the controller is removed, the participant will be charged by Desert Water Agency for the amount of the rebate.
- Regular maintenance and programming is the responsibility of the participant.
- Participant allows Desert Water Agency to contact them for research purposes regarding the controller.

Neither Desert Water Agency, nor their contractors or agents, makes any representation or warranty regarding the irrigation controller utilized in this Smart Controller Installation Program. By participating in the program, participants waive and release the DWA and their contractors and agents, from any and all claims and causes of action arising out of the purchase, installation or use of the irrigation controller used in connection with the program.
