

DESERT WATER  
  
TERMS AND CONDITIONS

ELIGIBILITY:

1. All commercial properties must be located within Desert Water Agency's service area.
2. Applicants must fill out and sign application within 30 days of purchasing the toilet(s).
3. Limit is thirty (30) toilet replacements per commercial property.
4. Applicant agrees to purchase and install toilet at customer's expense before rebate is guaranteed.
5. Toilets must be purchased after July 1, 2016.
6. Application must be submitted within 30 days after the purchase.
7. The program is not for new construction and is not retroactive to previously purchased toilets.
8. Qualifying toilets must be High-Efficiency models with 1.28 gallons per flush or less.  
High-Efficiency toilets are available in:
  - Gravity-Fed
  - Pressure Assist
  - Dual-Flush
9. Applicant must provide a copy of their receipt or paid sales invoice indicating the make and model purchased from a home improvement store or other retail outlet that sells new toilets. For toilets purchased through a plumber or contractor, a copy of the invoice from the contractor with the make, model, and cost of each toilet stamped "Paid in Full" will be acceptable as proof of payment.
10. Applicant agrees that if all conditions are met with this program and funding is available, the Agency shall reimburse an amount up to \$100.00 for each toilet or the cost of the purchase of up to thirty (30) toilets, whichever amount is less. Desert Water Agency will not reimburse for the cost of recycling an old inefficient toilet or the cost of installation.
11. Applicant has read and agrees to the program conditions and the following disclaimer:  
**Desert Water Agency offers this program on a first-come, first-served basis and rebates depend on availability of funds.** By participating in the program, you waive and release Desert Water Agency from any and all claims and causes of action arising out of the purchase, installation, or use of the High-Efficiency toilet. Any claim you may have based upon any defect or failure of the performance of the High-Efficiency toilet purchased by you in conjunction with this program shall be pursued with the retail outlet and the manufacturer. Additionally, the applicant agrees to allow Desert Water Agency use of information related to the applicant's participation in the program for promotional purposes.

**Desert Water Agency: Commercial Water Conservation Toilet Replacement Program**

**ABOUT THE PROGRAM:**

Desert Water Agency is incentivizing commercial properties in its service area to replace inefficient toilets with High-Efficiency (1.28 gallons per flush or less). The Agency will offer up to a maximum of \$100.00 per toilet to replace inefficient toilets. Applicants are limited to thirty (30) toilet replacements per commercial property and must apply within 30 days of purchase. Applicants are responsible for installation, submission of sales receipt, and/ or any other pertinent documents. The Agency will reimburse the applicant after all program conditions have been met. **This program is offered on a first-come, first-served basis and rebates depend on availability of funds.**

**HOW TO APPLY:**

1. Read the Terms and Conditions on the reverse side. Eligibility requirements must be met to participate.
2. Complete this application and submit it with a copy of your receipt to the Agency via the contact information found at the bottom of this page.
3. If you qualify and funding is available, your rebate check will be mailed to you within 45 days.
