Secretary-Treasurer Ewing reported that the Operating Fund received \$2,552,636 in Water Sales Revenue, \$141,545 in Reclamation Sales Revenue, \$2,569 from SCE for Snow Creek Hydro Power Sales and \$613,271 from the General Fund. Included in the Miscellaneous receipts were \$151,260 from Desert Horizons for sewer charges. Year-to-date Water Sales are 5% under budget; Year-to-date Total Revenues are 4% under budget; and Year-to-date Total Expenses are 15% under budget. There were 22,620 active services as of December 31, 2018.	Operating Fund
Reporting on the General Fund, Mr. Ewing stated that $$5,122,401$ was received in Property Tax Revenue, $$2,135$ in Groundwater Assessments for private pumpers and $$805,618$ was paid out in State Water Project charges (YTD = $$7,659,727$).	General Fund

Mr. Riddell provided a background on Desert Water Agency Law and explained the California Voting Rights Act of 2001. He stated on December 26, 2018, the Agency received a letter from an attorney	Transition to Elections of Directors by Division

representing the Southwest Voter Registration Education Project, which A claims the Agency's "at-large" system of voting dilutes the ability of Latinos to elect candidates of their choice or to otherwise influence the outcome of the Agency's elections.

Continuing his report, Mr. Riddell stated Resolution No. 1201 expresses the Board's intention to undertake the steps prescribed by Elections Code Section 10010 for a transition from "at-large" elections to elections by division. In anticipation of the adoption of Resolution No. 1201, the agenda also provides for immediately conducting the first of two public hearings that must occur before a draft map or maps showing possible division boundaries can be prepared, as provided in the resolution. Staff recommends adoption of Resolution No. 1201 and the use of a professional demographer for further guidance in this matter.

Karl Baker, Desert Hot Springs resident, spoke in support of Karl Baker the resolution and expressed his willingness to work with the Board

Director Oygar made a motion to approve staff's recommendation. Secretary-Treasurer Ewing seconded the motion, which carried unanimously.

Mr. Krause provided background regarding the Sites Reservoir Project, Phase 1 proposal to participate. He explained on August 16, 2018, the Reservoir Committee approved the proposed Sites Reservoir Authority, 2019 Reservoir Project Agreement. Based on the proposed 2019 agreement, the Agency is obligated to pay up to \$60 per acre-foot or \$390,000 in calendar year 2019. This would be in addition to the \$315,250 for Phase 1 (\$48.5 per acre-foot) for a total obligation of \$705,250. Staff recommends entering into the Sites Project Authority, 2019 Reservoir Project Agreement and requests authorization for the General Manager to execute said agreement.

<u>California WaterFix Update</u> From the Sacramento Bee, by Dale Kasler:

Gov. Gavin Newsom, diving into one of California's most contentious water issues, said Tuesday he wants to downsize the Delta tunnels project. The Democratic governor also set out to overhaul state water policy by naming a new chair of the state's water board.

Newsom said he wants the twin-tunnel project — designed to <u>re-engineer the troubled estuary</u> that serves as the hub of California's elaborate water-delivery system — reduced to a single tunnel.

"I do not support the WaterFix as currently configured," Newsom said during his first State of the State address, using the official term for the Delta project. "Meaning, I do not support the twin tunnels. We can build, however, on the important work that's already been done. That's why I do support a single tunnel."

The announcement likely means WaterFix would require a fresh set of environmental reviews before it can proceed, translating into additional delays for a project that's been in the planning stage for more than a decade and will take an estimated 15 years to build.

Supplemental Water Supplies (Article 21)

On February 12th the Department of Water Resources sent out notice 19-05 regarding the 2019 Article 21 Water Program. The notice states that due to the current water conditions and storage in San Luis Reservoir, it is likely that Article 21 water may become available south of the Sacramento-San Joaquin Delta during 2019.

We are currently discussing with MWD the possibility that we may participate in this program. MWD is currently assessing its carryover situation with respect to participation in the Article 21 program.






STAFF REPORT TO DESERT WATER AGENCY BOARD OF DIRECTORS

FEBRUARY 19, 2019

RE: JANUARY 2019 WATER USE REDUCTION FIGURES

Desert Water Agency and its customers achieved a 19.4% reduction in potable water production during January 2019 compared to the same month in 2013 – the baseline year used by the State Water Resources Control Board (State Water Board) to measure statewide conservation achievements. DWA continues to report its production to the state on a monthly basis, despite mandatory conservation ending in 2017.



DWA is asking its customers to save 10-13% compared to 2013 to help achieve long-term sustainability.

The cumulative savings over the last twelve-month period is 14.6%. The cumulative savings beginning in June of 2016 when we put our 10-13% target in place is 16.5%.

Historically, DWA has submitted data based on the permanent population of the service area; however, that data does not accurately reflect water use in DWA's service area which has a highly seasonal population. Based on local data, the correct population is higher than previously reported. The Residential Gallons Per Capita Per Day (R-GPCD) is being submitted using the corrected population.

Since Desert Water Agency began recycling water, the agency has reclaimed 99,354 acre feet. If our recycled water production for this month was taken into consideration against our potable production, the conservation achieved would have been several percentage points higher.

In the 2018 water year, October to mid-June, we have lost about a million acre feet due to biological opinions (regulatory restrictions). Please see the graph on the following page.
