General Manager's 19020. President Bloomer called upon General Manager Krause to Report provide an update on Agency operations.

Mr. Krause provided an update on Agency operations and noted his meetings and activities for the past several weeks.

Public Comment

Steve Grasha expressed his condolences regarding Mr. Luker.

There being no one else from the public wishing to address the Board, President Bloomer closed the public comment period.

President Bloomer called upon Secretary-Treasurer Stuart to 19023. present an overview of financial activities for the month of December 2020.

Secretary-Treasurer's Report (December)

Secretary-Treasurer Stuart reported that the Operating Fund received \$3,426,475 in Water Sales Revenue, \$93,018 in Reclamation Sales Revenue, \$4,723 from SCE for Snow Creek Hydro Power Sales for November 2020, \$41,095 in Construction Deposits and \$4,986 in Miscellaneous for Verizon settlement. \$1,888,196 was paid out in Accounts Payable. Year-todate Water Sales are 8% over budget, Year-to-date Total Revenues are 7% over budget; and Year-to-date Total Expenses are 13% under budget. There were a total of 22,988 active services as of December 31, compared to 22,948 active services as of November 30.

Operating Fund

Reporting on the General Fund, Mr. Stuart stated that \$416,526 was received in Groundwater Assessments from Private Pumpers, 5,657,644 in Property Tax Revenues, and \$45,569 from SCE for Whitewater Hydro Power Sales for November 2020. \$1,608,493 was paid in State Water Project charges (YTD \$10,118,955).

General Fund

Reporting on the Wastewater Fund, Mr. Stuart reported \$106 was received in Sewer Contract payments. There are a total of 4 Sewer Contracts, 0 paid in full, with total delinquents of 4 (100%) with \$897 principal payments remaining. \$97,728 was paid out in Accounts Payable.

19025. President Bloomer called upon Finance Director Saenz to present staff's request for Board Approval for Extension of COVID-19 Financial Relief to Customers.

Request Board Approval for Extension of COVID-19 Financial Relief to Customers

Mrs. Saenz gave an update on the financial impact COVID-19 has had on the Agency. She stated that the Agency will continue to monitor the ongoing revenue losses and expenses related to COVID-19 and will provide ongoing updates to the Board. She noted that staff will bring this item back to the Board of Directors for consideration at its March 16 meeting. Staff will also continue to monitor the ongoing revenue losses and expenses related to COVID-19 and will provide ongoing updates to the Board.

Items for Action: Request Board Approval for Extension of COVID-19 Financial Relief to Customers

Staff recommends that the Board of Directors extend financial relief for customers (suspension of late fees, disconnection of service for nonpayment and absorption of remote payment fees) for an additional 56 days, from January 20 through March 16;

Director Oygar moved for approval of staff's recommendation. After a second by Director Ortega, the motion carried by the following roll call vote:

In response to Director Ortega, Mrs. Saenz explained that staff is looking into a longer payment term when the financial relief is lifted.

Vice President Cioffi noted that he would like to revisit extending the payment terms when financial relief is lifted.

President Bloomer called upon Assistant General Manager Acceptance of 19026. Johnson to present staff's request for Acceptance of the 2019/2020 Replacement Pipeline Avenida Caballeros 30" Pipeline (Vista Chino to Tachevah Drive).

2019/2020 Replacement Pipeline Avenida

Mr. Johnson reported the 2019/2020 Replacement Pipeline Avenida Caballeros 30" Pipeline has been completed. The pipeline was put into service on November 3, 2020 noting that the pavement rehabilitation is complete and all remaining punch list items are expected to be completed within two weeks. He explained that all project work was performed by Jones Bros Construction Co. and to date, no stop notices have been filed with the Agency. Mr. Johnson added that the budget was based on an original Engineer's construction cost estimate of \$2,950,000. Prior to advertising for this project, Krieger & Stewart re-evaluated the Engineer's estimate based on bid prices that they were observing for other pipeline projects and adjusted their Engineer's estimate to \$1,750,000. He explained that when the project was awarded, staff anticipated having approximately \$1,100,000 remaining in the budget. The actual amount of money remaining in the budget after construction is \$1,650,000 and it will be reallocated for future pipeline replacement projects.

Items for Action: (Cont.) Acceptance of 2019/2020 Replacement Pipeline Avenida Caballeros

Staff recommends the Board accept said work in the amount of \$1,691,024.57. Subsequent to Board acceptance, a Notice of Completion will be filed and the Agency will make final payment to Jones Bros Construction Co. Thereafter, following the lien period, the Agency will release retained funds.

ACWA/JPIA Award



Palm Springs Unified School District Science Fair

DWA participated virtually as a judge in the Palm Springs Unified School District 2021 District Science Fair on January 21st. The Agency honored 7th grader Nazeli Geragos from Cielo Vista Charter School in Palm Springs. Nazeli tested various types of water on plants to find out if different types of water affect plant growth. Her project determined spring water, with its amount of hardness and sulfates, contribute to optimal plant growth. She will receive an award certificate and gift card from DWA.





<u>Update - FEMA Assistance – February 14, 2019 Flood Damage</u>

Background:

On Valentine's Day of 2019, a storm caused incredible flooding and damage in the Coachella Valley. Several Desert Water Agency facilities were affected. On May 1, 2019, FEMA declared the flooding event a major disaster.

In June 2019, after learning that the City of Palm Springs was working with FEMA on assistance for flood remediation, staff submitted a formal Request for Project Assistance with FEMA. The request was submitted one day after the application period ended and was formally denied on August 28. DWA submitted a formal appeal and worked with Water Strategies to obtain a letter of support from Congressman Dr. Raul Ruiz. That appeal was submitted on October 2, 2019 and rejected on January 2, 2020. On July 13, 2020, FEMA representatives contacted staff to notify DWA that its Request for Project Assistance would be considered.

The Agency may be able to obtain 75% reimbursement for its flood at Snow Creek remediation (intake and bridge repairs) and on Cathedral Canyon Drive (sewer line response and repairs). This work amounted to approximately \$195,000 (approximately \$170,000 for Snow Creek and \$25,000 for Cathedral Canyon Drive).

DWA may also get reimbursement for work that has yet to be done to repair damage at the Falls Creek and Chino Creek North intakes and Whitewater Mutual system. Staff is working to develop cost estimates for the damage repairs at the three other sites.

While funding is not guaranteed at this point, staff has already begun the documentation and work needed to solicit reimbursement. Staff will inform the Board as milestones within the FEMA grant process are met.

Attached is a letter from the California Office of Emergency Services (Cal OES) that includes the formal FEMA appeal approval.

Update:

On January 21, 2021 the California Office of Emergency Services informed us that Desert Water Agency's request for public assistance for the Mid-February 2019 storm damage has been approved by the Federal Emergency Management Agency (FEMA). The Agency must now provide the necessary documents for approval of funding.
