19285. President Bloomer called upon Director of Public Affairs & Water Planning Metzger to present her report on the Statewide Drought Emergency Declaration.

Discussion Item: Statewide Drought **Emergency Declaration**

Mrs. Metzger reported that on October 19, Governor Newsom declared a statewide drought emergency, bringing Riverside County and the other 7 counties not yet declared into the drought emergency. In the Executive Order, the Governor required all California water agencies to evaluate their Water Shortage Contingency Plans that take into account local conditions and anticipate continued dry years. She noted that DWA is collaborating with other Agencies to submit updated planning documents for groundwater sustainability within the coming months.

In response to Director Ortega and Vice President Cioffi, Mrs. Metzger stated that Mission Springs Water District has a similar plan as DWA and that she has plans on connecting with the City of Cathedral City and Riverside County once the item is agendized.

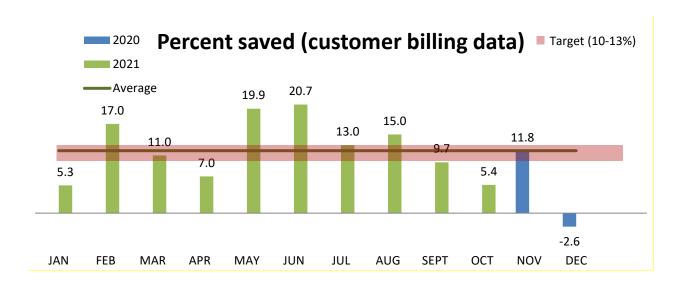

STAFF REPORT TO DESERT WATER AGENCY BOARD OF DIRECTORS

NOVEMBER 16, 2021

RE: OCTOBER 2021 WATER USE REDUCTION FIGURES

Desert Water Agency customers achieved a 5.4% reduction in metered potable water consumption during October 2021 compared to the same month in 2013 – the baseline year the State Water Resources Control Board (State Water Board) used to measure statewide conservation achievements during the last drought.



Over the past 12 months, consumption is trending 11.9% lower compared to 2013. DWA is asking its customers to voluntarily save 10-13% compared to 2013 to help achieve long-term sustainability.

While overall water use is down 5.4% in October 2021 compared to October 2013, if we account for the new meters/customers since 2013, the reduction is roughly 25%. The Governor has asked Californians to voluntarily conserve 15% compared to last year.

DWA per customer usage is down 5% compared to last October. Though we're encouraging and incentivizing conservation, there is presently no requirement for the Agency or any of its customers to meet a certain savings requirement.

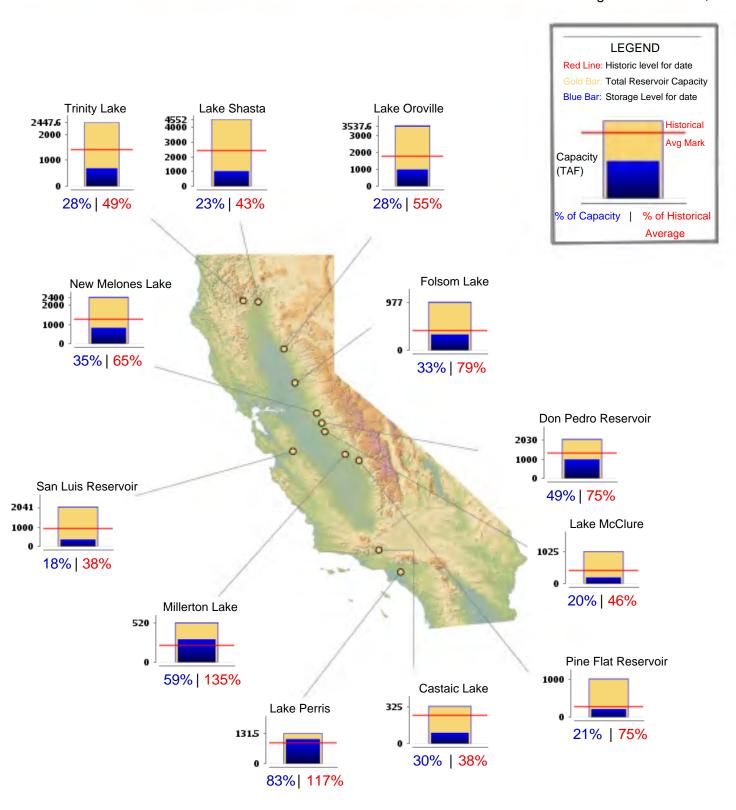




CURRENT RESERVOIR CONDITIONS

RE: REQUEST AUTHORIZATION FOR GENERAL MANAGER TO SIGN MEMORANDUM OF UNDERSTANDING AS A CVRWMG MEMBER ON PROPOSITION 1 ROUND 1 IRWM FUNDING SPLIT

Desert Water Agency is a member of the Coachella Valley Regional Water Management Group (CVRWMG) and is able to solicit state grant funding earmarked for Integrated Regional Water Management (IRWM).

Proposition 1 divided California into 12 funding areas and CVRWMG is in the Colorado River Funding Area (CRFA).

Within the funding area, there are three active IRWM groups: CVRWMG, Mojave RWMG and San Gorgonio RWMG. In the past, CVRWMG has solicited funding via funding splits like proposed in the attached MOU and has also gone after funding competitively if the parties could not reach a funding split agreement.

When soliciting funding competitively the project scores are critical to getting as much funding for the region as possible, as is a diverse project portfolio. When a funding split agreement is in place, the region has more flexibility with the projects it elects to advance. A funding split agreement brings more certainty to the amount of money available to the CVRWMG Region, and thus DWA.

Available currently to the CRFA via Proposition 1 Round 2 is \$8,538,265. Coachella Valley, Mojave and San Gorgonio RWMGs have agreed upon a tentative funding split to be finalized with the execution of the attached MOU.

At this time, the CVRWMG has not decided on a list of projects for this funding round. We do not know how much funding will be available to Desert Water Agency or what projects will be included. Staff plans to propose grass removal funding as part of the CV Water

Counts regional campaign. Staff will inform the Board of Directors when CVRWMG has finalized its application to the Department of Water Resources.

Fiscal Impact:

Not yet determined. Finance Director Saenz has reviewed this report.

Recommendation:

Staff recommends that the Board of Directors authorize General Manager Krause to sign the MOU as a CVRWMG member agency.

MEMORANDUM OF UNDERSTANDING FOR INTEGRATED REGIONAL WATER MANAGEMENT PLANNING AND FUNDING IN THE COLORADO RIVER BASIN FUNDING AREA

This Memorandum of Understanding (MOU) is entered into this 9th day of November 2021 (Effective Date) among the Parties listed below:

PARTIES:

Mojave Water Agency, hereinafter MWA; Victor Valley Wastewater Reclamation Authority, hereinafter VVWRA; Technical Advisory Committee, hereinafter TAC; Mojave Desert Resource Conservation District, hereinafter Mojave Desert RCD; and Morongo Basin Pipeline Commission.

3. San Gorgonio RWMG, hereinafter SGRWMG, includes the following member agencies which are each a Party to this MOU:

City of Banning, hereinafter Banning; Banning Heights Mutual Water Company, hereinafter BHMWC; High Valleys Water District, hereinafter HVWD, Riverside County Flood Control and Water Conservation District, hereinafter RCFCWCD; and the San Gorgonio Pass Water Agency, hereinafter SGPWA.

The RWMG agencies acting collectively under this agreement are the COLORADO RIVER INTEGRATED REGIONAL WATER MANAGEMENT PARTIES, hereinafter called the Colorado River IRWM Parties. The RWMG agencies also are sometimes referred to in this MOU collectively as "Parties" and individually as "Party."

RECITALS:

- A. The Water Quality, Supply, and Infrastructure Improvement Act of 2014 (Public Resources Code, sections 79740-79744) (Proposition 1), authorizes the Legislature to appropriate funding for competitive grants for Integrated Regional Water Management (IRWM) projects. Funding is administered by the Department of Water Resources (DWR).
- B. The intent of Proposition 1 is, in part, to encourage integrated regional strategies for management of water resources and to provide funding through competitive grants, for projects that protect communities from drought, protect and improve water quality, promote environmental stewardship, and improve local water security by reducing dependence on imported water.

- C. The Colorado River Basin Hydrologic Region, also known as the Colorado River Funding Area, is composed of the IRWM regions the CVRWMG, MRWMG, and SGRWMG. The boundaries of the CVRWMG, MRWMG, and SGRWMG are shown in **Attachment A.** Each IRWM region has been accepted into the IRWM Grant Program via the Region Acceptance Process.
- D. For the purposes of this 2021 MOU, the division of funding and terms of the funding agreement among the Colorado River IRWM regions shall be consistent with terms articulated in **Attachment B**, which are summarized below:

- E. Each Party has adopted an accepted IRWM Plan pursuant to Water Code § 10530 et seq. The Parties now desire coordination of applications for the Proposition 1 Round 2 Implementation grants to fund projects to enhance the quality of planning, identify opportunities for supporting common goals and projects, and improve the quality and reliability of water in the Colorado River Funding Area and throughout the State of California. The Parties will each rank and select projects for inclusion in IRWM grant applications for their region consistent with their respective IRWM Plans. The Parties will also submit a Proposition 1 Round 2 Implementation grant application to DWR individually for their respective RWMGs.
- F. The Parties will balance the necessary autonomy of each planning region to plan for itself at the appropriate scale with the need to coordinate among themselves to improve inter-regional cooperation and efficiency. By consensus, the Parties have developed the 2021 MOU to improve the IRWM planning process in the Funding Area to coordinate planning across planning region lines and facilitate the appropriation of funding for IRWM projects by DWR.
- G. The Parties will coordinate on grant funding requests to ensure that the sum of the total grant requests does not exceed the amount designated for the funding region.

The RECITALS are incorporated herein and the PARTIES hereby mutually agree as follows:

1. Definitions

The following terms and abbreviations, unless otherwise expressly defined by their context, shall mean:

- A. Funding Area refers to any one of the 12 regions and sub-regions referenced in Public Resources Code section 79744(b) and allocated a specific amount of funding to support IRWM activities. The Colorado River Basin Hydrologic Region (also referred to as Colorado River Funding Area) incorporates lands in the Colorado River Basin Regional Water Quality Control Board.
- B. **RWMG** refers to a group of at least three agencies, two of which must have statutory authority over water management, that have joined together to manage water resources to meet regional

- needs. Each RWMG is the documented leader of IRWM planning and implementation efforts in a planning region.
- C. **Planning Region** –refers to regions with integrated stakeholders, agencies and projects in their regions for the purpose of coordinating with other planning regions and DWR. The boundaries of the three planning regions in the Colorado River Funding Area are shown in **Attachment A**.
- D. Colorado River Integrated Regional Water Management Parties (Colorado River IRWM Parties) refers collectively to the three RWMGs entering into this MOU. The Colorado River IRWM Parties is composed of at least one representative from each recognized RWMG in the Funding Area. The Colorado River IRWM Parties will meet periodically to discuss issues pertaining to the Funding Area and make recommendations to the RWMGs.
- E. **Stakeholder Advisory Committee** refers to the recognized committee or committees of stakeholders advising a planning region's RWMG and/or governing agencies on key issues related to IRWM planning and grant applications.

2. General Planning Cooperation via Colorado River IRWM Parties

All RWMGs will meet on an as-needed basis through the Colorado River IRWM Parties. The number and timing of meetings will depend on the amount and intensity of planning and coordination efforts of the planning regions. The efforts of the Colorado River IRWM Parties will be to coordinate on IRWM-related funding efforts, enhance the quality of planning, and identify opportunities for supporting common goals and projects in the Funding Area.

3. Scope of the Agreement

Nothing contained within this MOU binds the Parties beyond the scope or term of this MOU unless the Parties expressly so agree in subsequent agreements, amendments, or contracts. This MOU does not require any commitment of funding beyond that which is voluntarily committed by separate board actions, but recognizes in-kind contributions of RWMG agencies and stakeholders.

4. Term of Agreement

The term of this MOU is from its Effective Date set forth above to the end of the fund expenditure date included in the Proposition 1 Round 2 Implementation Grant Proposal Solicitation Package (PSP) unless extended or terminated by mutual agreement of the Parties.

5. Modification or Termination

This MOU may be modified or terminated with the concurrence of the RWMGs. Modification or termination shall be effective upon execution of a written agreement by all the RWMGs.

6. Notice

Any notices sent or required to be sent to any RWMG shall be mailed and electronically mailed to the representatives designated for each member agency of the RWMGs.

7. Funding Uncertainties

The RWMGs do not guarantee that these coordination efforts and applications for funding will result in actual funding of any specific project. Nothing in this MOU shall be construed as creating a promise or guarantee of future funding. No liability or obligation shall accrue to any Party if DWR does not provide funding in response to any Party's application. The Parties are committed to planning and

coordinating notwithstanding IRWM funding. The form of such coordination may change based on the sources of funding.

8. Indemnification

To the fullest extent permitted by law, each Party shall defend, indemnify and hold harmless the other Parties, their consultants, and each of their directors, officers, agents, and employees from and against all liability, claims, damages, losses, expenses, and other costs including costs of defense and attorneys' fees, arising out of or resulting from or in connection with work performed pursuant to this MOU. Such obligation shall not apply to any loss, damage, or injury, as may be caused by the sole negligence or willful misconduct of a Party, its directors, officers, employees, agents, and consultants.

9. Miscellaneous Provisions

- A. **Governing Law:** This MOU is to be construed in accordance with the laws of the State of California. Any action at law or in equity brought by any of the Parties shall be brought in a court of competent jurisdiction in Imperial, Riverside, or San Bernardino Counties, and the parties hereto waive all provisions of law providing for change of venue in such proceedings to any other county.
- B. **Severability and Validity of Provisions:** If any provision of this MOU is held by a court to be invalid, void or unenforceable, the remaining provisions shall be declared severable and shall be given full force and effect to the extent possible.
- C. **Arms' Length Negotiations:** This MOU is the result of negotiations between the parties hereto and with the advice and assistance of their respective counsels. No provision contained herein shall be construed against any Party because of its participation in preparing this MOU.
- D. **Waiver:** Any waiver by a Party of any breach by the other of any one or more of the terms of this MOU shall not be construed to be a waiver of any subsequent or other breach of the same or of any other term hereof. Failure on the part of any of the respective Parties to require from the others exact, full and complete compliance with any terms of the MOU shall not be construed to change the terms hereof or to prohibit the Party from enforcement hereof.
- E. Execution in Parts or Counterparts: This MOU may be executed and delivered in any number of parts or counterparts, hereinafter called "Counterpart". When each Party has signed and delivered at least one Counterpart to the other parties hereto, each Counterpart shall be deemed an original and, taken together, shall constitute one and the same MOU, which shall be binding and effective as to the Parties hereto. Facsimile or electronic signatures shall be binding.
- F. **Exclusive Expression of Agreement:** This MOU is intended by the parties hereto as their final expression with respect to the matters herein, and is a complete and exclusive statement of the terms and conditions thereof. This MOU shall not be changed or modified except by the written consent of all Parties hereto.

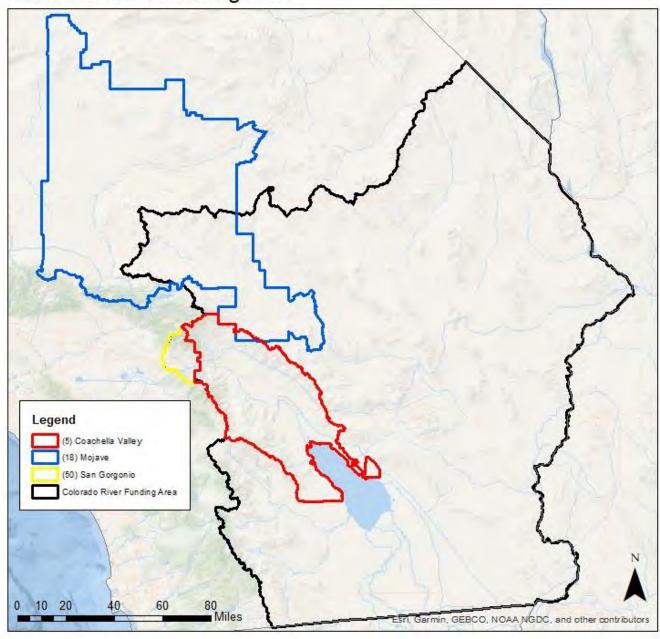

Attachment B Allocation and Use of Proposition 1 Funds

Per the December 2019 Proposition 1 Round 1 Implementation Grant Proposal Solicitation Package, a total of \$16,401,530 for Proposition 1 Implementation grants in the CRFA with a total of \$2,250,000 was available for funding of DAC implementation projects and \$14,151,130 for funding general implementation projects. In Round 1, DWR awarded \$7,863,265 to the CRFA with a total of \$787,500 from the available DAC funding and \$7,075,765 from the available general implementation funding. For Round 2, there is a total of \$8,538,265 remaining with \$1,462,500 from the available DAC funding and \$7,075,765 from the available general implementation project funding. The remaining funding will be distributed through the Proposition 1, Round 2 Implementation Grant Solicitation(s), which is anticipated to occur in 2022. This MOU addresses only the Proposition 1, Round 2 Solicitation, which will be allocated in accordance with the amounts shown in the following table. Any unallocated funds will be distributed proportionately to the regions.

STAFF REPORT TO DESERT WATER AGENCY BOARD OF DIRECTORS

RE: REQUEST AUTHORIZATION FOR GENERAL MANAGER TO EXECUTE QUITCLAIMS TERMINATING EASEMENT INTEREST WITHIN PROPERTY OWNED BY THE AGUA CALIENTE BAND OF CAHUILLA INDIANS FOR THE CATHEDRAL CITY CASINO PROJECT

In December 2019, the Agency received a notification from the City of Cathedral City (Attachment #1) regarding the vacation of right of ways and easements for city streets and alleyways within the proposed ACBCI Casino Project. In addition, the Tribe requested the Agency terminate pipeline easements within the proposed Project for the purpose of clearing title.

The Agency has two separate easements located within the project area. An easement originating from a Grant Deed recorded on October 8, 1926 and a Grant of Easement recorded on March 1, 2010. The easements are generally located on the Northwest corner of the intersection of East Palm Canyon Drive and Date Palm Drive. Two separate Quitclaim Deeds (Exhibit #1 and Exhibit #2, attached), will be required to terminate the easement interests.

The 1926 easement held by the Agency was acquired from the Palm Springs Water Company and the Cathedral City Water Company for the purpose of supplying water and maintaining water facilities that served the area. The facilities that were located within the project area have been relocated or were abandoned in place as part of the project. Although the facilities are no longer within the project area, the quitclaim documents allow the Agency to retain ownership of "All water and all rights to develop water in or upon the property" as described in the 1926 deed.

The 2010 easement held by the Agency was acquired for the purpose of installing and maintaining water and sewer pipelines in the area. The facilities within this easement were not needed for the project and the facilities were abandoned in place.

Fiscal Impact: None

Recommendation:

Staff recommends Board of Directors authorize the General Manager to execute quitclaims terminating easement interests within property owned by ACBCI for the Cathedral City Casino Project.

Ref: Vacation No. 2019-01: REQUEST FOR COMMENTS: Proposed vacation of portions of Hillery Road (formerly First Street) and Grove Street, east of Monty Hall Drive; a public alley between Hillery Road and Grove Street, and various public utility easements reserved from previous vacations of portions of Hillery Road, Grove Street, Dawes Street, Allen Avenue, and other easements for street and utility purposes. Applicant: Agua Caliente Band of Cahuilla Indians (ACBCI)

Dear Mark,

The City is working with the Agua Caliente Band of Cahuilla Indians to clear its recently acquired properties for commercial development. These properties include most of the lots between Date Palm Drive and Monty hall Drive, and between Buddy Rogers Drive and East Palm Canyon Drive.

Two previous vacation proceedings were conducted in this area, and most of the streets and easements were vacated, as described in the two enclosed recorded City Council Resolutions, No. 2015-49A and 2017-11A, both of which were recorded on August 10, 2017, as Instruments No. 2017-0330780 and 0330781, in Official records.

Although the streets and alleys described in these resolutions were vacated, utility easements over many of the streets and alleys were reserved to protect the existing sewer, water, Edison, telephone, gas and cable TV facilities in them.

The development of the area is now in full swing, and all the existing utilities are in the process of being removed or relocated. Therefore, the utility easements reserved from the prior vacations can now be considered for vacation.

In addition, the ACBCI has recently acquired additional property at the northeast corner of Monty Hall and East Palm Canyon. The Tribe has requested the vacation of all or portions of the streets and alleys in that newly acquired area.

All of the streets, alleys easements and reserved utility easements now being considered for vacation are described in the legal descriptions attached as Exhibit "A" and shown on the sketch attached as Exhibit "B".

It's our understanding that the Tribe has or is making arrangements with all involved utility companies to relocate or remove all the existing underground and overhead utilities within the areas shown on the sketch.

Adoption of a formal Resolution of Intention is scheduled for the December 11, 2019, City Council meeting. The final public hearing is scheduled for January 22, 2020.

This vacation will likely be processed with several conditions to be met prior to the recordation of the vacation and the actual abandonment of the streets and alleys and easements included. These conditions would include:

- a. That the vacation of the streets, alleys, easements and reserved utility easements would not become effective until all sewers, water mains, gas lines, and other underground and overhead utility lines and facilities in them have been removed, relocated, or abandoned, or utility easements have been provided to their owners for any remaining facilities, all to the satisfaction of the respective utility owners;
- b. That as the above conditions are met in any portion or portions of the above listed streets, alleys and easements, the vacation of that portion or portions could become effective by the recordation of a City Council resolution describing that portion only.

Therefore, the City asks that you please review the enclosed materials and your records, and If you have any objection to the proposed vacations or wish to continue using any of the streets, alleys or easements for your present facilities, to please respond accordingly and include plans, records, documents, atlas sheets or other information to explain your concerns and show your facilities.

Please be specific as to your usage of each street and block. Also please let us know which, if any, of your facilities are already scheduled to be relocated or removed by the ACBCI as part of their ongoing development.

Please send back any response within 30 days of your receipt of this letter, but please, not later than by Monday, January 13, 2020. If no comments are returned by Monday, January 13, 2020, we will assume you have no objections to the proposed vacations.

Funds Managed by Contracted Parties - LAIF

The Desert Water Agency has contracted with the California Local Agency Investment Fund (LAIF) for investment of Agency funds. LAIF is a voluntary program created by Section 16429.1 et seq. of the California Government Code. LAIF is an investment alternative for California's local governments and special districts. This program offers local agencies the opportunity to participate in a major portfolio, which invests hundreds of millions of dollars, using the investment expertise of the state Treasurer's Office professional investment staff at no additional cost to the taxpayer or ratepayer. All Agency funds invested with LAIF are available for withdrawal upon demand and may not be altered, impaired or denied in any way (California Government Code Section 16429.4).

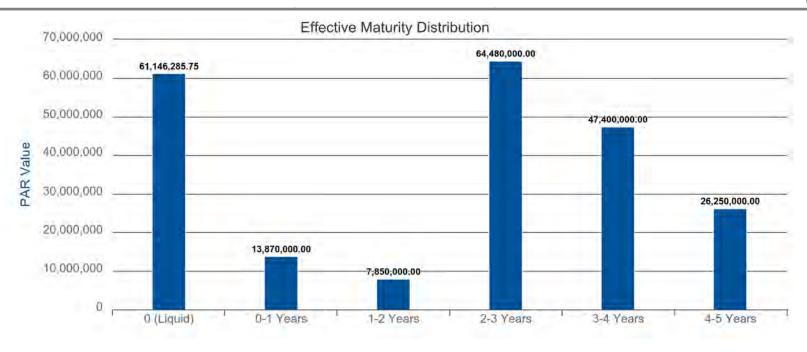

GENERAL MANAGER'S REPORT November 16, 2021

Damaged Hydrant (N. Zanjero Rd. & W. Cortez Rd.)

On November 2 at approximately 7:40 a.m., Construction staff responded to a hit fire hydrant at the northwest corner of N. Zanjero Rd. and W. Cortez Rd. The water flowed for approximately 30 minutes from a fully open 6-inch fire hydrant bury. The hydrant was replaced and put back into service. A police report was filed.





Damaged Wall at Well #8 (NW corner of Sunrise Way and Alejo Rd.)

On November 4 at approximately 11:00 p.m., the Palm Springs Police Department notified DWA that a car crashed into Well #8's block wall, which is on the NW corner of Sunrise Way and Alejo Rd. If it is determined that the driver has insurance, an insurance claim will be filed. The Agency will be hiring a contractor to repair the wall.





Damaged Hydrant (1322 S. Farrell Dr.)

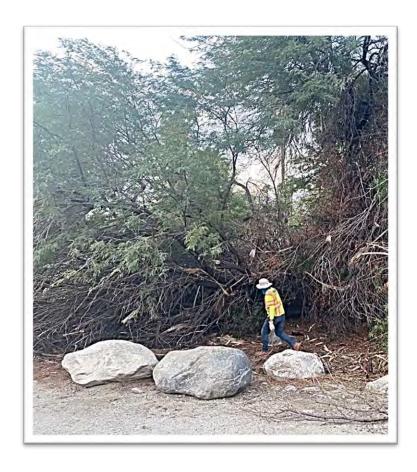
On November 10 at approximately 12:00 a.m. Construction staff responded to a hit fire hydrant at 1322 S. Farrell Dr. on the east side of S. Farrell Dr. between San Mateo Dr. and E. Sonora Rd. The water flowed for approximately 20 minutes from a fully open 6-inch fire hydrant bury. Staff reinstalled the fire hydrant and put it back in service. A police report was filed.



Palm Springs North High Fire Hazard Abatement Project (Phase 2)

This second phase is a continuation of the Agency's efforts to comply with an order by the PSFD to reduce the potential for fire hazards on the site. Phase 2 is a combined effort of Down To Earth Landscaping and Pompa Tree Service. The areas of focus for this phase are from the southwest corner, east, about 550 feet along southern fence line, approximately 1.5 acres in size. Phase 2 should be completed by the end of November. Below are before and after photos of the project. Phase 2 cost is \$90,000. Phase 1 costs were \$88,000. To date the agency has spent a total of \$178,000 on mitigating potential landscape fire hazards on site. There are two additional phases of the project that will be budgeted for in the coming years.











<u>Site Vandalism – San Joaquin Dr. (Dream Homes)</u>

DWA has been monitoring one of its future well sites located on San Joaquin Dr. on the north side of Dream Homes, about 150 yards east of Well 41. Down To Earth Landscaping (DWA's landscaper) visits the site regularly to keep weeds down. They recently notified DWA of damages to the locks on the gates and other vandalism, including graffiti, and even small homeless encampments along with debris and several shopping carts from local business establishments. The graffiti and encampments were cleaned up and the locks repaired, replaced and hardened. However, over the weekend of November 6, the drive gate lock was removed and someone gained access to the site with some form of off road vehicle. The Agency will be hardening the locking system for the drive gates soon.

Cathedral City Police and Code Enforcement have been notified of the situation and a request for a removal of the shopping carts near our site, and increased patrols has been submitted.









State Water Board Prepares to Adopt New Chrom-6 MCL

The State Water Board is proposing to adopt and implement a regulation that establishes the Maximum Contaminant Level (MCL) for hexavalent chromium (AKA Chromium-6) in drinking water. The State Board is the lead agency under CEQA and is preparing a Programmatic Environmental Impact Report for the adoption of the regulation. The State Water Board is considering 17 possible MCL's (1 to 15, 20 and 25 parts per billion). DWA has detected Chrom-6 in one standby well and one active well. The highest sample testing result in DWA groundwater wells is 6.5 ppb in the standby well. If the MCL is set low enough it could have significant impact on DWA. We are preparing a comment letter.

Polyethylene (PE) Service Replacement Update

From the early 1970's to the early 1980's, the Agency installed thousands of 1-inch and 2-inch polyethylene (PE) plastic services. As the PE services age, the pipe strength weakens and over time have resulted in numerous leaks throughout the system. When a PE service fails, it develops a split several inches long, releasing large quantities of water into the surrounding area. These leaks can produce devastating damaged to the roadway surface and can cause major flooding.

Over the past three years, the Agency's Construction Department has been focusing on PE service replacements, targeting neighborhoods and streets with many PE service installations and replacing the services with 1-inch or 2-inch copper tube service piping. In 2019, there were approximately 3,300 PE services remaining in the system.

In 2020, the Agency identified PE service replacements as work that could be completed safely under pandemic safety protocols. In June 2020, a combined total of 138 PE services (1-inch and 2-inch) were replaced. For the year 2020, the Construction Department replaced an average of 80 PE services per month and in 2021, the department is averaging 74 PE service replacements per month. Over the past three years, the Construction Department has averaged 58 service replacements per month and have replaced a total of 1,971, with a total budgeted amount of approximately \$2.65M.

Figures 1, 2, and 3 show the month by month PE service replacement numbers for calendar year 2019, 2020, and 2021, respectively. Figure 4 shows the cumulative number of PE services replaced by quarter (attached). At the current rate of replacement, we anticipate replacing all of the PE services by mid-year 2023.

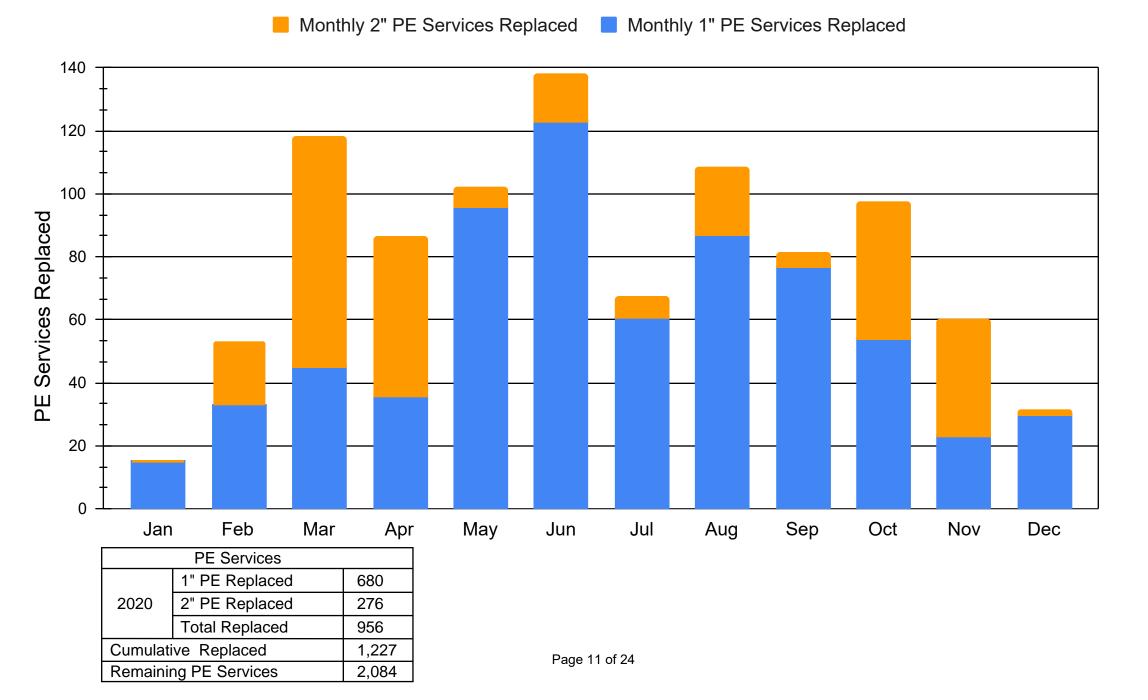

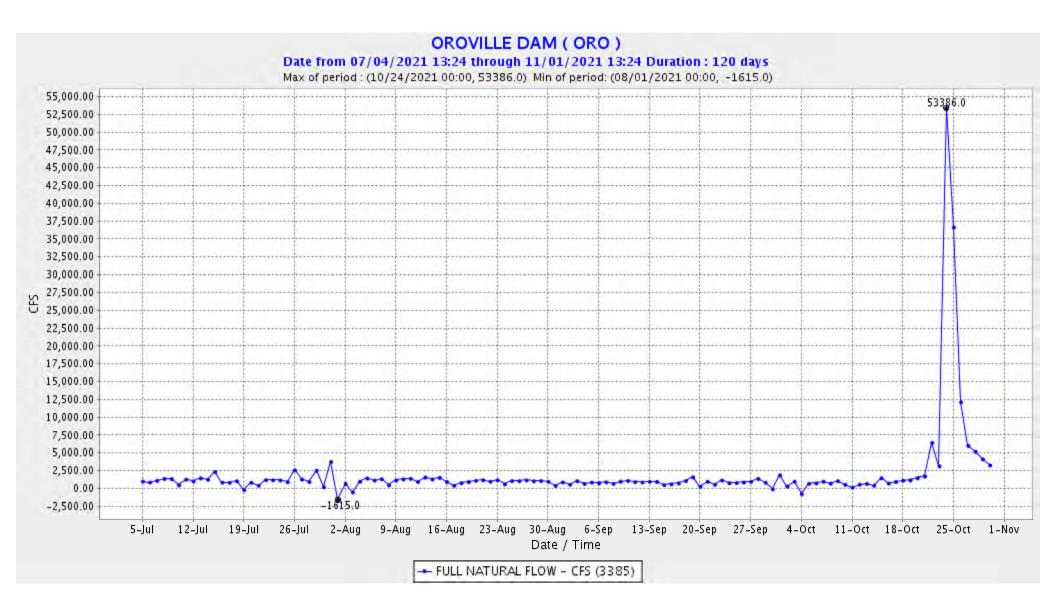
PE Services Replaced by Quarter

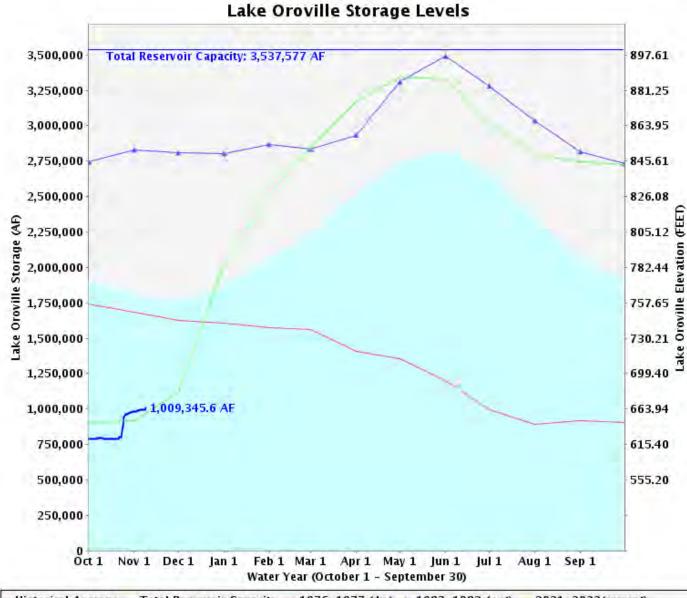

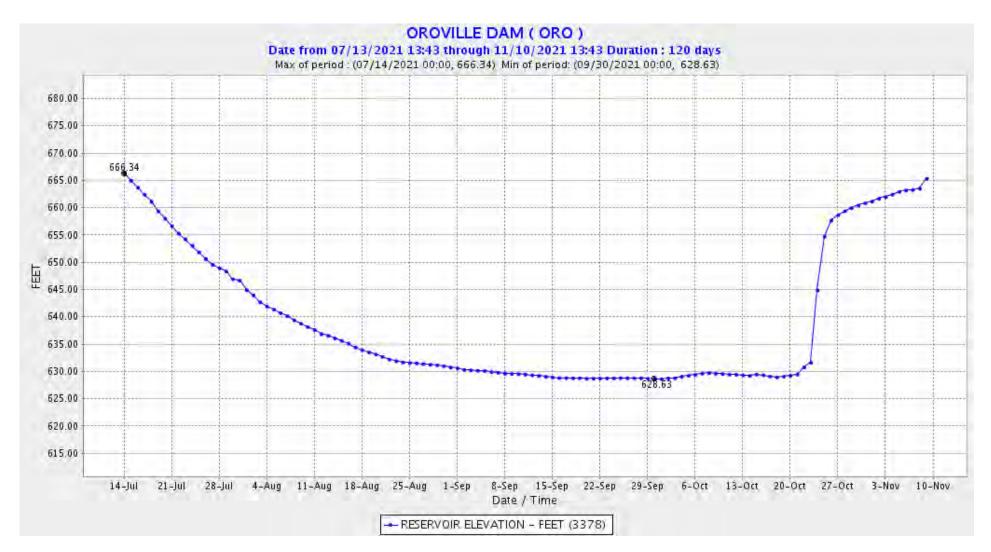
Lake Oroville Water Level

According to the Data on DWR's website, Lake Oroville's water level was near a record low at the beginning of October at an approximate elevation of 628.77 feet above MSL. An atmospheric river started adding significant runoff to the lake starting on October 23rd. By October 30th the lake level had risen 31.21 feet to an elevation of 659.98 feet above MSL and added 186,081 acre feet of storage to the reservoir. Precipitation this last week has also added runoff to the lake further raising the level to an elevation of 665.37 feet above MSL and adding 34,912 acre feet of storage to the reservoir. The generators had been turned off at the Edward Hyatt Power Plant at a water elevation of approximately 635 feet above MSL. Runoff peaked around October 24th at 53,386 cubic feet per second or about 9% of the average flow of the Mississippi River.

Infrastructure Investment and Jobs Act Passes

On November 5, the Infrastructure Investment and Jobs Act received enough votes to pass the United States House of Representatives. The Senate passed the infrastructure bill in August by a vote of 69-30. The following funding measures were included in the bill:

- \$8.3 billion for Bureau of Reclamation western water (Title IX)
- \$3.2 billion for Reclamation Aging Infrastructure (including \$2.2 billion for the revolving account)
- \$400 million for WaterSMART
 - \$100 million if that will be available for projects that would improve the condition of a natural feature or nature-based feature
- \$1.15 billion for Reclamation water storage, groundwater storage and conveyance projects
- \$110 billion in new funds for roads, bridges, and major projects
- \$1 billion for water recycling and reuse
- \$250 million for desalinization
- \$1 billion for rural water
- \$500 million for dam safety
- \$300 million for Drought Contingency Plan
- \$100 million for cooperative watershed management
- \$250 for Aquatic Ecosystem Restoration
- \$100 million -benefit watershed projects
- \$50 million for CO River fish recovery programs
- \$9.5 billion for US Army Corps of Engineers
- \$55 billion for clean drinking water
- \$3.3 billion for wildfire risk reduction

COVID Arrearage Payment Program Application Submission

On November 8, 2021, the Agency applied for \$343,500 in COVID relief funding through the California Water and Wastewater Arrearage Payment Program. \$333,500 will be applied to customer accounts that have outstanding water bills from March 4, 2020 to June 15, 2021. The remaining \$10,000 is for administrative costs associated with preparing the funding application and distributing the funding once received.

It is anticipated that the California Water and Wastewater Arrearage Payment Program will have funding remaining after all eligible community water systems have submitted and received funds. The remaining funds will be used to fund wastewater arrearages from March 4, 2020 to June 15, 2021 and water arrearages accumulated after June 15, 2021.
