

PETITION ASKING FOR THE ANNEXATION OF  
CERTAIN TERRITORY DESCRIBED AS THE FIRST FRINGE AREA  
TO DESERT WATER AGENCY

We, the undersigned, do hereby petition for the annexation to Desert Water Agency under the Desert Water Agency law, of certain unincorporated and inhabited territory which territory is particularly described below and is designated and referred to as "First Fringe Area", and we do certify and declare:

FIRST: That said "First Fringe Area" so proposed to be annexed to said Desert Water Agency comprises unincorporated and inhabited territory in the County of Riverside, State of California, and that no portion of said territory lies within the present corporate limits of said Desert Water Agency, and no portion of said territory lies within the corporate limits of any incorporated city.

The "First Fringe Area" proposed to be annexed to said Desert Water Agency is situated in the County of Riverside, State of California, and is more particularly described as follows:

Beginning at the northwest corner of Section 3, Township 2 South, Range 3 East, San Bernardino Base and Meridian;

(1) Thence easterly along the township line between Township 1 South and Township 2 South, Range 3 East, San Bernardino Base and Meridian, to the northwest corner of Section 1, Township 2 South, Range 3 East, San Bernardino Base and Meridian;

(2) Thence southerly along the west line of said Section 1, said last mentioned township and range, to the west quarter section corner thereof;

(3) Thence easterly along the east-west quarter section line of said Section 1 to the east quarter section corner thereof;

(4) Thence southerly along the range line between Range 3 East and Range 4 East in Township 2 South, San Bernardino Base and Meridian, to the northwest corner of Section 7, Township 2 South, Range 4 East, San Bernardino Base and Meridian;

(5) Thence easterly along the north line of said Section 7, said last mentioned township and range, to the northwest corner of Section 8, said last mentioned township and range;

(6) Thence southerly along the west line of said Section 8 to the west quarter section corner thereof;

(7) Thence easterly along the east-west quarter section line of said Section 8, to the east quarter section corner thereof;

(8) Thence southerly along the east line of said Section 8 to the southeast corner thereof;

(9) Thence easterly along the north line of Section 16, said last mentioned township and range, to the northeast corner thereof;

(10) Thence northerly along the west line of Section 10 and the west line of Section 3, said last mentioned township and range, to the northwest corner of said Section 3;

- (11) Thence easterly along the township line between Township 1 South and Township 2 South in Range 4 East, San Bernardino Base and Meridian, to the northeast corner of Section 1, Township 2 South, Range 4 East, San Bernardino Base and Meridian;
- (12) Thence along the range line between Range 4 East and Range 5 East, San Bernardino Base and Meridian, to the northwest corner of Section 6, Township 2 South, Range 5 East, San Bernardino Base and Meridian;
- (13) Thence easterly along the township line between Township 1 South and Township 2 South, Range 5 East, San Bernardino Base and Meridian, to the northeast corner of said Section 6;
- (14) Thence southerly along the east line of said Section 6 and the east line of Sections 7 and 18, said last mentioned township and range, to the southeast corner of said Section 18;
- (15) Thence easterly along the north line of Section 20 and the north line of Sections 21 and 22, said last mentioned township and range, to the northeast corner of said Section 22;
- (16) Thence southerly along the east line of said Section 22 and the east line of Sections 27 and 34, said last mentioned township and range, to the southeast corner of said Section 34;
- (17) Thence along the township line between Township 2 South and Township 3 South, in Range 5 East, San Bernardino Base and Meridian, to the northeast corner of Section 3, Township 3 South, Range 5 East, San Bernardino Base and Meridian;
- (18) Thence southerly along the east line of said Section 3 to the southeast corner thereof;
- (19) Thence easterly along the north line of Section 11, said last mentioned township and range, to the northeast corner thereof;
- (20) Thence southerly along the east line of said Section 11 to the southeast corner thereof;
- (21) Thence easterly along the north line of Section 13, said last mentioned township and range, to the northeast corner thereof;
- (22) Thence southerly along the range line between Range 5 East and Range 6 East, in Township 3 South, San Bernardino Base and Meridian, to the southeast corner of Section 25, Township 3 South, Range 5 East, San Bernardino Base and

Meridian;

(23) Thence westerly along the south line of said Section 25, and the south line of Sections 26, 27, 28, and 29, said last mentioned township and range, to the southwest corner of said Section 29;

(24) Thence northerly along the west line of said Section 29 to the northwest corner thereof;

(25) Thence westerly along the south line of Section 19, said last mentioned township and range, to the southwest corner thereof;

(26) Thence along the range line between Range 4 East and Range 5 East in Township 3 South, San Bernardino Base and Meridian, to the southeast corner of Section 24, Township 3 South, Range 4 East, San Bernardino Base and Meridian;

(27) Thence westerly along the south line of said Section 24 to the southwest corner thereof;

(28) Thence northerly along the west line of said Section 24 to the northwest corner thereof;

(29) Thence easterly along the north line of said Section 24 to the northeast corner thereof;

(30) Thence along the range line between Range 4 East and Range 5 East in Township 3 South, San Bernardino Base and Meridian, to the northwest corner of Section 19, Township 3 South, Range 5 East, San Bernardino Base and Meridian;

(31) Thence easterly along the north line of said Section 19 to the northeast corner thereof;

(32) Thence southerly along the east line of said Section 19 to the east quarter section corner thereof;

(33) Thence easterly along the east-west quarter section line of Section 20, said last mentioned township and range, to the east quarter section corner thereof;

(34) Thence northerly along the west line of Section 21 and the west line of Section 16, said last mentioned township and range, to the northwest corner of said Section 16;

(35) Thence easterly along the north line of said Section 16 to the southwest corner of the southeast quarter of the southeast quarter of the southwest quarter of Section 9, said last mentioned township and range;

- (36) Thence northerly along the west line of said southeast quarter of the southeast quarter of the southwest quarter to the northwest corner thereof;
- (37) Thence westerly along the south line of the north half of the south half of the southwest quarter of said Section 9 to a point in the west line of said Section 9;
- (38) Thence northerly along the west line of said Section 9 to the west quarter section corner thereof;
- (39) Thence easterly along the east-west quarter section line of said Section 9 to the southwest corner of the east half of the northwest quarter thereof;
- (40) Thence northerly along the west line of the said east half of the northwest quarter to the northwest corner thereof;
- (41) Thence westerly along the south line of Section 4, said last mentioned township and range, to the southeast corner of the southwest quarter of the southwest quarter of the southwest quarter of Section 4;
- (42) Thence northerly along the east line of said southwest quarter of the southwest quarter of the southwest quarter to the northeast corner thereof;
- (43) Thence westerly along the north line of said southwest quarter of the southwest quarter of the southwest quarter of said Section 4 to the northwest corner thereof;
- (44) Thence southerly along the west line of said Section 4 to the southwest corner thereof;
- (45) Thence westerly along the south line of Section 5, said last mentioned township and range, to the south quarter section corner thereof;
- (46) Thence northerly along the north-south quarter section line of said Section 5 to the north quarter section corner thereof;
- (47) Thence along the township line between Township 2 South and Township 3 South to the south quarter section corner of Section 32, Township 2 South, Range 5 East, San Bernardino Base and Meridian;
- (48) Thence northerly along the north-south quarter section line of said Section 32 to the northeast corner of the south half of the north half of the southwest quarter thereof;

(49) Thence westerly along the north line of said south half of the north half of the southwest quarter to the northwest corner thereof;

(50) Thence northerly along the west line of said Section 32 to the west quarter section corner thereof;

(51) Thence westerly along the east-west quarter section line of Section 31, said last mentioned township and range, to the west quarter section corner thereof;

(52) Thence southerly along the range line between Range 4 East and Range 5 East, Township 2 South, San Bernardino Base and Meridian, to the southeast corner of Section 36, Township 2 South, Range 4 East, San Bernardino Base and Meridian, said southeast corner also being the northwest corner of Section 6, Township 3 South, Range 5 East, San Bernardino Base and Meridian;

(53) Thence easterly along the township line between Township 2 South and Township 3 South in Range 5 East, San Bernardino Base and Meridian, to the north quarter section corner of said Section 6;

(54) Thence southerly along the north-south quarter section line of said Section 6 to the south quarter section corner thereof;

(55) Thence westerly along the south line of said Section 6 to the southwest corner thereof;

(56) Thence along the range line between Range 4 East and Range 5 East in Township 3 South, San Bernardino Base and Meridian, to the southeast corner of Section 1, Township 3 South, Range 4 East, San Bernardino Base and Meridian;

(57) Thence westerly along the south line of said Section 1 and the south line of Sections 2, 3, and 4, said last mentioned township and range, to the southwest corner of said Section 4;

(58) Thence northerly along the west line of said Section 4 to the northwest corner thereof;

(59) Thence westerly along the township line between Township 2 South and Township 3 South, Range 4 East, San Bernardino Base and Meridian, to the southwest corner of Section 31, Township 2 South, Range 4 East, San Bernardino Base and Meridian;

(60) Thence northerly along the range line between Range 3 East and Range 4 East in Township 2 South, San Bernardino Base and Meridian, to the east quarter

section corner of Section 13, Township 2 South, Range 3 East, San Bernardino Base and Meridian;

(61) Thence westerly along the east-west quarter section line of said Section 13 to the west quarter section corner thereof;

(62) Thence northerly along the west line of said Section 13 and the west line of Section 12, said last mentioned township and range, to the west quarter section corner of said Section 12;

(63) Thence westerly along the east-west quarter section line of Section 11, said last mentioned township and range, to the west quarter section corner thereof;

(64) Thence northerly along the west line of said Section 11 to the north-west corner thereof;

(65) Thence westerly along the south line of Section 3, said last mentioned township and range, to the southwest corner thereof;

(66) Thence northerly along the west line of said Section 3 to the north-west corner thereof, said corner also being the point of beginning.

EXCEPTING THEREFROM that portion of Section 35, Township 2 South, Range 4 East, San Bernardino Base and Meridian, more particularly described as follows, and shown as EXCLUDED PARCEL NO. 1;

Beginning at the southeast corner of said Section 35;

feet to the northeast corner thereof;

Thence southerly along the east line of said Parcel 14, a distance of 332.93 feet to the southeast corner thereof;

Thence westerly along the south line of said Parcel 14, a distance of 621.04 feet to a point in the west line of said Section 35;

Thence southerly along said west line of Section 35 to the southwest corner thereof;

Thence easterly along the south line of said Section 35 to the point of beginning;

Thence easterly along the east-west quarter section line of said Section 11 to the northwest corner of the east half of the southeast quarter of said Section 11;

Thence southerly along the west line of said east half of the southeast quarter to the southwest corner thereof;

Thence easterly along the south line of said Section 11 to the point of beginning;

Thence South  $46^{\circ} 19' 57''$  East, a distance of 674.80 feet to a point in the southerly line of said Section 3, said point being South  $89^{\circ} 54' 50''$  West, a distance of 905.66 feet, measured along said southerly line from the southeast corner of said Section 3;

The sidelines of said strip of land, 150.00 feet wide, shall be prolonged or shortened so as to terminate in said westerly line of Section 4 and in said southerly line of Section 3;

ALSO INCLUDING that certain non-contiguous parcel of land described as follows and shown as INCLUDED PARCEL NO. 1;
