ORDINANCE NO. 2

AN ORDINANCE GRANTING THE PETITION FOR ANNEXA-TION TO DESERT WATER AGENCY OF CERTAIN TERRITORY DESIGNATED AS THE FIRST FRINGE AREA, FIXING THE TERMS AND CONDITIONS UPON WHICH SUCH ANNEXATION MAY OCCUR AND DESCRIBING THE BOUNDARIES OF THE FIRST FRINGE AREA.

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF DESERT WATER AGENCY AS FOLLOWS:

WHEREAS, On the 16th day of March, 1962 there was filed with the Secretary of this Agency a Petition signed by certain qualified electors residing within certain territory described and referred to therein as the First Fringe Area and hereinafter more particularly described, which First Fringe Area lies wholly within the County of Riverside, State of California, being the County in which this Agency is situated, praying that all the territory comprising said First Fringe Area be annexed to Desert Water Agency; and

WHEREAS, The Secretary of this Agency has completed his examination of said Petition and has attached his Certificate thereto, properly dated, showing the result of said examination and certifying said petition to be sufficient, and duly and regularly set said petition for hearing before the Board of Directors of this Agency at a meeting of said Board to be held at 190 Amado Road, in the City of Palm Springs, County of Riverside, State of California, on Tuesday,

the low day of April, 1952 at the hour of 8:00 o'clock Alk; and

WARREAS, by letter dotted April 9, 1952 proposed by the Commella County Mater to the Desert Mater Agency and presented at the regular assuing of this Agency on April 10th, 1952 said Commella District Stated that the consent of that District has not been obtained ad to the annountion of certain parochs of land which were also included within the Commella Districts will

WHEREAS, On request by this Agency of the Coachella District a map and legal description have been delivered indicating six (6) parcels of land in the proposed First Fringe Area which are also included in the Coachella District, and it further appearing upon investigation that said annexations of said parcels by the Coachella District were carried out without the consent of the Board of Directors of the Desert Hot Springs County Water District as required by Section 30165 of the County Water District Law; and

WHEREAS it appears to be for the best interest of this Agency not to involve itself in disputes between the Coachella District and the Desert Hot Springs County Water District and for that reason to exclude from the proposed First Fringe Annexation those areas which appear to be in conflict between the two existing County water districts;

WHEREAS, The Board of Directors of said Desert Hot Springs County Water District has heretofore indicated its willingness to consent, pursuant to the provisions of Section 36 of the Desert Water Agency Law, to the annexation of the lands represented by said District to said Desert Water Agency, and

WHEREAS, Said Petition was duly presented to this Board and hearing thereon was duly held at a regularly adjourned meeting of this Board held at 8:00 o'clock A.M. on Tuesday, the 17th day of April, 1962, at 190 Amado Road, in

the City of Palm Springs, County of Riverside, State of California; and this Board being now duly and regularly convened and regularly in session at said time and place;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF DESERT WATER AGENCY AS FOLLOWS:

Section 1. That said Petition filed on the 16th day of March, 1962 with the Secretary of this Agency duly and regularly prays that said First Fringe Area be annexed to Desert Water Agency; that no portion of said First Fringe Area is now included within or is a part of a corporate area of Desert Water Agency; that said Petition and all matters in connection with the circulating, signing, filing, certifying and presenting of said Petition and the giving of notice in connection with its presentation to this Board are regular and valid and are sufficient in law; and this Board of Directors of Desert Water Agency has jurisdiction of the subject matter and has jurisdiction to entertain and to grant said Petition.

Section 2. That said Petition so filed on the 16th day of March, 1962 with the Secretary of this Agency praying that all the territory referred to and described therein and hereinafter more particularly described be annexed to and become a part of the Desert Water Agency he and the same is hereby granted, to the limit and extent of the territory hereinafter described.

Section 3. That the terms and conditions upon which said annexation of said First Fringe Area to Desert Water Agency may occur are hereby ordered and fixed by this Board of Directors as follows:

The only term and condition upon which said annexation is predicated shall be that prior to said annexation the written consent of Desert Hot Springs County Water District to said annexation be given, said consent to be evidenced by resolution duly adopted by the Board of Directors of said District pursuant to the provisions of Section 36 of the Desert Water Agency Law.

Section 4. That the boundaries of the territory herein and in said Petition described and referred to as the First Fringe Area and sought to be annexed to Desert Water Agency as prayed for in said Petition are as follows:

Section 5. That an election be called by this Board of Directors of Desert Water Agency and shall be held within said First Fringe Area, described as aforesaid, which said election shall be held within 70 days after the effective date of this Ordinance. At said election the proposition of the annexation of said First Fringe Area to Desert Water Agency subject to the terms and conditions herein fixed by said Board of Directors of Desert Water Agency, as hereinabove set forth, shall be submitted to the vote of the electors in said First Fringe Area.

Section 6. This is an Ordinance calling an election and shall go into effect immediately.
