That on the *23rd* day of July, 1962, pursuant to the provisions of the Desert Water Agency Law, entitled:

"An Act creating the Desert Water Agency, and prescribing its boundaries, organization, operation, management, financing and other powers and duties,"

approved July 11, 1961, (Act 9097 of Deering's General Laws),

There was filed in my office the Certificate of Herbert Samson and Edgar L. McCoubrey, as President and Secretary respectively of the Board of Directors of the Desert Water Agency, dated July 10, 1962, relating to the Annexation to the Desert Water Agency of the "First Fringe Area" of the Desert Water Agency.

I further certify that said Certificate contains a copy of Ordinance No. 2 entitled:

"AN ORDINANCE GRANTING THE PETITION FOR ANNEXATION TO DESERT WATER AGENCY OF CERTAIN TERRITORY DESIGNATED AS THE FIRST FRINGE AREA, FIXING THE TERMS AND CONDITIONS UPON WHICH SUCH ANNEXATION MAY OCCUR AND DESCRIBING THE BOUNDARIES OF THE FIRST FRINGE AREA."


passed and adopted by the Board of Directors on the 17th day of April, 1962, which said Ordinance granted the Petition for said annexation to the Desert Water Agency of the First Fringe Area of the Desert Water Agency, and set forth the terms and conditions fixed by the Board of Directors of the

Desert Water Agency for the annexation of the First Fringe Area of the Desert Water Agency, and also set forth and described the boundaries of said First Fringe Area of the Desert Water Agency.

I further certify that said Certificate contains a record of the canvass of the returns of a Special Election which was consolidated with the statewide primary election held in the First Fringe Area of the Desert Water Agency on the 5th day of June, 1962, by the County Clerk of Riverside County, at which Special Election the proposition of the annexation of said First Fringe Area of the Desert Water Agency to the Desert Water Agency, subject to the terms and conditions fixed by the Board of Directors of said Agency was submitted to the electors thereof, and that it was shown therein and thereby that said proposition was approved by a majority of the electors voting thereon at said Special Election.

I further certify that there is attached to said Certificate the Certificate of the County Recorder of the County of Riverside, State of California, being the county in which the corporate area of the Desert Water Agency and the said First Fringe Area of the Desert Water Agency are situated, stating and declaring that on the 13th day of July, 1962, there was presented to and left with him the Certificate of said President and Secretary of the Board of Directors of the Desert Water Agency, the same being a duplicate of the Certificate filed in this office.

NOW, THEREFORE, I further certify by reason of the facts and proceedings set forth in the required Certificate of the President and Secretary of the Board of Directors of the Desert Water Agency and the filing thereof in my office, that the territory described therein and which is situated in the County of Riverside, State of California, has been annexed to the Desert Water Agency, the description of such territory, known as the First Fringe Area of the Desert Water Agency, being as follows:

(1) Thence easterly along the township line between Township 1 South and Township 2 South, Range 3 East, San Bernardino Base and Meridian, to the northwest corner of Section 1, Township 2 South, Range 3 East, San Bernardino Base and Meridian;

(2) Thence southerly along the west line of said Section 1, said last mentioned township and range, to the west quarter section corner thereof;

(3) Thence easterly along the east-west quarter section line of said Section 1 to the east quarter section corner thereof;

(4) Thence southerly along the range line between Range 3 East and Range 4 East in Township 2 South, San Bernardino Base and Meridian, to the northwest corner of Section 7, Township 2 South, Range 4 East, San Bernardino Base and Meridian;

(5) Thence easterly along the north line of said Section 7, said last mentioned township and range, to the northwest corner of Section 8, said last mentioned township and range;

(6) Thence southerly along the west line of said Section 8 to the west quarter section corner thereof;

(7) Thence easterly along the east-west quarter section line of said Section 8, to the east quarter section corner thereof;

(8) Thence southerly along the east line of said Section 8 to the southeast corner thereof;

(9) Thence easterly along the north line of Section 16, said last mentioned township and range, to the northeast corner thereof;

(10) Thence northerly along the west line of Section 10 and the west line of Section 3, said last mentioned township and range, to the northwest corner of said Section 3;

(11) Thence easterly along the township line between Township 1 South and Township 2 South in Range 4 East, San Bernardino Base and Meridian, to the northeast corner of Section 1, Township 2 South, Range 4 East, San Bernardino Base and Meridian;

(12) Thence along the range line between Range 4 East and Range 5 East, San Bernardino Base and Meridian, to the northwest corner of Section 6, Township 2 South, Range 5 East, San Bernardino Base and Meridian;

(13) Thence easterly along the township line between Township 1 South and Township 2 South, Range 5 East, San Bernardino Base and Meridian, to the northeast corner of said Section 6;

(14) Thence southerly along the east line of said Section 6 and the east line of Sections 7 and 18, said last mentioned township and range, to the southeast corner of said Section 18;

(15) Thence easterly along the north line of Section 20 and the north line of Sections 21 and 22, said last mentioned township and range, to the northeast corner of said Section 22;

(16) Thence southerly along the east line of said Section 22 and the east line of Sections 27 and 34, said last mentioned township and range, to the southeast corner of said Section 34;

(17) Thence along the township line between Township 2 South and Township 3 South, in Range 5 East, San Bernardino Base and Meridian, to the northeast corner of Section 3, Township 3 South, Range 5 East, San Bernardino Base and Meridian;

(18) Thence southerly along the east line of said Section 3 to the southeast corner thereof;

(19) Thence easterly along the north line of Section 11, said last mentioned township and range, to the northeast corner thereof;

(20) Thence southerly along the east line of said Section 11 to the southeast corner thereof;

(21) Thence easterly along the north line of Section 13, said last mentioned township and range, to the northeast corner thereof;

(22) Thence southerly along the range line between Range 5 East and Range 6 East, in Township 3 South, San Bernardino Base and Meridian, to the southeast corner of Section 25, Township 3 South, Range 5 East, San Bernardino Base and

Meridian;

(23) Thence westerly along the south line of said Section 25, and the south line of Sections 26, 27, 28, and 29, said last mentioned township and range, to the southwest corner of said Section 29;

(24) Thence northerly along the west line of said Section 29 to the northwest corner thereof;

(25) Thence westerly along the south line of Section 19, said last mentioned township and range, to the southwest corner thereof;

(26) Thence along the range line between Range 4 East and Range 5 East in Township 3 South, San Bernardino Base and Meridian, to the southeast corner of Section 24, Township 3 South, Range 4 East, San Bernardino Base and Meridian;

(27) Thence westerly along the south line of said Section 24 to the southwest corner thereof;

(28) Thence northerly along the west line of said Section 24 to the northwest corner thereof;

(29) Thence easterly along the north line of said Section 24 to the northeast corner thereof;

(30) Thence along the range line between Range 4 East and Range 5 East in Township 3 South, San Bernardino Base and Meridian, to the northwest corner of Section 19, Township 3 South, Range 5 East, San Bernardino Base and Meridian;

(31) Thence easterly along the north line of said Section 19 to the northeast corner thereof;

(32) Thence southerly along the east line of said Section 19 to the east quarter section corner thereof;

(33) Thence easterly along the east-west quarter section line of Section 20, said last mentioned township and range, to the east quarter section corner thereof;

(34) Thence northerly along the west line of Section 21 and the west line of Section 16, said last mentioned township and range, to the northwest corner of said Section 16;

(35) Thence easterly along the north line of said Section 16 to the southwest corner of the southeast quarter of the southeast quarter of the southwest quarter of Section 9, said last mentioned township and range;

(36) Thence northerly along the west line of said southeast quarter of the southeast quarter of the southwest quarter to the northwest corner thereof;

(37) Thence westerly along the south line of the north half of the south half of the southwest quarter of said Section 9 to a point in the west line of said Section 9;

(38) Thence northerly along the west line of said Section 9 to the west quarter section corner thereof;

(39) Thence easterly along the east-west quarter section line of said Section 9 to the southwest corner of the east half of the northwest quarter thereof;

(40) Thence northerly along the west line of the said east half of the northwest quarter to the northwest corner thereof;

(41) Thence westerly along the south line of Section 4, said last mentioned township and range, to the southeast corner of the southwest quarter of the southwest quarter of the southwest quarter of Section 4;

(42) Thence northerly along the east line of said southwest quarter of the southwest quarter of the southwest quarter to the northeast corner thereof;

(43) Thence westerly along the north line of said southwest quarter of the southwest quarter of the southwest quarter of said Section 4 to the northwest corner thereof;

(44) Thence southerly along the west line of said Section 4 to the southwest corner thereof;

(45) Thence westerly along the south line of Section 5, said last mentioned township and range, to the south quarter section corner thereof;

(46) Thence northerly along the north-south quarter section line of said Section 5 to the north quarter section corner thereof;

(47) Thence along the township line between Township 2 South and Township 3 South to the south quarter section corner of Section 32, Township 2 South, Range 5 East, San Bernardino Base and Meridian;

(48) Thence northerly along the north-south quarter section line of said Section 32 to the northeast corner of the south half of the north half of the southwest quarter thereof;

(49) Thence westerly along the north line of said south half of the north half of the southwest quarter to the northwest corner thereof;

(50) Thence northerly along the west line of said Section 32 to the west quarter section corner thereof;

(51) Thence westerly along the east-west quarter section line of Section 31, said last mentioned township and range, to the west quarter section corner thereof;

(52) Thence southerly along the range line between Range 4 East and Range 5 East, Township 2 South, San Bernardino Base and Meridian, to the southeast corner of Section 36, Township 2 South, Range 4 East, San Bernardino Base and Meridian, said southeast corner also being the northwest corner of Section 6, Township 3 South, Range 5 East, San Bernardino Base and Meridian;

(56) Thence along the range line between Range 4 East and Range 5 East in Township 3 South, San Bernardino Base and Meridian, to the southeast corner of Section 1, Township 3 South, Range 4 East, San Bernardino Base and Meridian;

(57) Thence westerly along the south line of said Section 1 and the south line of Sections 2, 3, and 4, said last mentioned township and range, to the southwest corner of said Section 4;

(58) Thence northerly along the west line of said Section 4 to the northwest corner thereof;

(59) Thence westerly along the township line between Township 2 South and Township 3 South, Range 4 East, San Bernardino Base and Meridian, to the southwest corner of Section 31, Township 2 South, Range 4 East, San Bernardino Base and Meridian;

(60) Thence northerly along the range line between Range 3 East and Range 4 East in Township 2 South, San Bernardino Base and Meridian, to the east quarter

section corner of Section 13, Township 2 South, Range 3 East, San Bernardino East and Meridian;

(61) Thence westerly along the east-west quarter section line of said Section 13 to the west quarter section corner thereof;

(62) Thence northerly along the west line of said Section 13 and the west line of Section 12, said last mentioned township and range, to the west quarter section corner of said Section 12;

(63) Thence westerly along the east-west quarter section line of Section 11, said last mentioned township and range, to the west quarter section corner thereof;

(64) Thence northerly along the west line of said Section 11 to the north-west corner thereof;

(65) Thence westerly along the south line of Section 3, said last mentioned township and range, to the southwest corner thereof;

(66) Thence northerly along the west line of said Section 3 to the north-west corner thereof, said corner also being the point of beginning.
